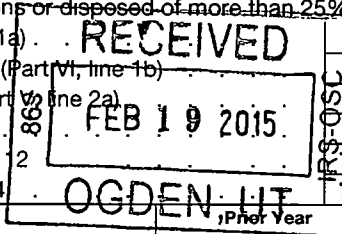

Job coaching and job placement services aid refugees and immigrants in becoming genuinely self-sufficient through intensive case management and high-individualized support. Refugees were served from Bhutan, Burma/Myanmar, Burundi, Democratic Republic of Congo, Ethiopia, Sudan, and Togo. In 2014, Nations Ministry Center continued the DREAM Fund which provided vocational training. In this short-year (January 1, 2014-June 30, 2015), the program had 40 job placements and provided about \$200,000 in additional income for refugee families. The program also provided 775 consultations.

Nations Academy after-school and summer programming includes homework help, mentoring, and summer reading programs. The program served 35 during this short, 6-month financial year. The program helps children become better readers and connects them to successful schools. 63 volunteers gave 925 hours which resulted in 2,289 hours of assistance. Children mastered 80 Lexia reading levels.

For this short financial year, Nations Ministry Center's family services provided consultations and immigration legal services to client to help them overcome barriers to genuine self-sufficiency. These services include applying for green cards and US citizenship. Nations Ministry Center is accredited by the Department of Justice Board of Immigration Appeals to provide legal immigration services.
