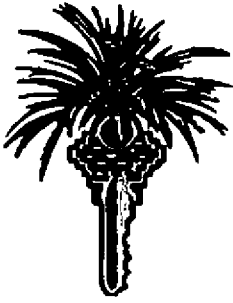

The following is from Community Housing & Resources, Inc. By-Laws.

ARTICLE 2. MEMBERSHIP

(1) Rights and Privileges

The Corporation shall have one class of members, and no more than one membership may be held by one person. The rights and privileges of all members shall be equal. Each member shall be entitled to one vote.

(2) Restrictions of Membership

No member shall have any right, title, or interest in any of the property or assets, including any earnings or investment income of this Corporation, nor shall any of such property or assets be distributed to any member on the dissolution or winding up thereof.

(3) Debts, Liabilities and Obligations

No member of this Corporation shall be personally liable for any of its debts, liabilities, or obligations, nor shall any member be subject to any assessment.

(4) Termination of Membership

Membership in this Corporation is nontransferable. Membership shall terminate on the resignation or death of a member or on his failure to pay the required dues within 30 days of the due date. Individuals whose membership has been terminated may apply for reinstatement in the same manner as application is made for initial membership.

(4) Nomination and Election of Directors

a. Nomination of Directors may be made by the Nominating Committee or by nomination from the floor at the Annual meeting. The slate of the Nominating Committee shall be mailed with the notice of the Annual Meeting. All nominees shall be members in good standing with the Corporation.

b. Nominees shall be submitted to a vote of the membership at the Annual Meeting.
