Caregiver Respite Program: provided non-acute, non-medical in-home caregiving services to 400 homebound seniors and seniors
with chronic illnesses and/or disabilities by matching them with trained volunteers. Services included phone reassurance calls,
home visits, errands that included grocery shopping, light house keeping, yard work, home safety repairs, bill paying, meal
preparation, Medi-Cal (Medicaid) application assistance, information and referral, respite for family caregivers. Provide more than
10,800 calls and more than 3700 hours of home visits.

Ride with Pride Program: provided curb-to-curb, door-to-door, door-through-door medical rides for ambulatory seniors who do not
or no longer can drive. Door-through-door transport was for homebound seniors enrolled in the Caregiver Respite Program and curb-
to-curb rides include those enrolled in the Senior Peer Counseling Program who were accessing mental health services. Seniors
could also be transported to life enhancement activities, such as the bookstore, libraries, hair salons, etc. Approximately 6,800 rides
were provided by volunteers.

Senior Peer Counseling: provided in-home peer counseling to 7 homebound seniors and their family caregivers dealing with
early on-set or milde mental health issues, such as depression, sadness, and loneliness. The program also provide group
counseling to 68 seniors who dealt with grief and loss, caregivers' stress, the impact of isolation. The agency also spent time in 2014
designing and implementing a new strategy within this program -- Senior Voices. Once implemented, the new strategy will enable
homebound seniors who wish to participate in groups to access groups by calling a toll-free number
