2014 was a momentous year for Garden City Harvest with programmatic growth and achievements in land security PROGRAMS The Community Gardens program offers people the opportunity to grow food to feed their own families In 2014, we rented 355 garden plots at eight community garden locations, up from 315 plots the previous year In an end-of-year survey, 71% of the community gardeners indicated they were from low to moderate income households and were able to save as much as \$20 per week on their grocery bills by gardening in this way 98% of the community gardeners said gardening improved the quality of their lives overall Also in 2014, Garden City Harvest partnered with St Patrick Hospital to construct a therapeutic-oriented community garden adjacent to the Providence Center, a campus of Patrick Hospital Roughly 5,000 students participated in Farm to School programs in 2014 They visited our farms on educational farm field trips, participated in structured educational school garden programming, and explored connections between farming and the food they eat through in-school lessons Construction took place on a new school garden at Hawthorne Elementary School in the spring of 2014 Our Farmer in the Classroom included over 600 second-graders in 33 classrooms throughout Missoula in the 2014-2015 school year Through this program, our farmer educators provide hands-on curriculum that encourages and entices second graders to learn about local agriculture and good nutrition Garden City Harvests four neighborhood farms grew tons (literally!) of produce, making it accessible to all community members, regardless of income We grew over 40,000 pounds of veggies that were distributed to a number of local service agencies, and to low-income senior citizens through a mobile farm stand We sold CSAs (or veggie subscriptions) to more people than ever before The farms also served as outdoor classrooms, offering hands-on, experiential learning opportunities to young and old Twenty teens were hired to work on our farms through our Youth Development programs in 2014 In addition, another 25-30 teens volunteered on a weekly basis throughout the growing season The youth all learned to grow food, from seed to harvest, and to cook and prepare healthy meals among other things The Mobile Market continues to be the cornerstone of our Youth Development programs It allows for growth by teaching teens a variety of job and life skills and it allows youth to be involved in service to others The youth make meaningful connections within the greater community, and seniors gain access to affordable, fresh produce right outside their door Through these interactions friendships form as the two groups share stories and recipes LAND SECURITY In February 2014, Garden City Harvest purchased the land on which the 3.5 acre River Road Farm operates The farm has existed at this site since 1996, but its future was uncertain until the purchase Now it is the only space of land owned by Garden City Harvest In an historical move, 2006 Open Space bond funds were used, in part, to help make the purchase, thereby preserving the site for farming and gardening for all Missoulians in perpetuity In December 2014, the City of Missoula and Missoula County Public Schools (MCPS), with the help of Garden City Harvest, came to an agreement in which MCPS will lease the property on which the PEAS Farm operates for the next 40 years The lease, which took effect on January 1, 2015, was drafted between MCPS and the City, the City sub-leases to Garden City Harvest
