Membership Services - We provide an environment where people passionate about Fiber Arts can create; shop a retail store filled with supplies and tools (including locally sourced and processed fiber); have access to studio space; and sell their work at on consignment. EVFAC also organizes regular shows and exhibitions (public events) that promote Members' creative work to the general public. EVFAC also has artist studio space that is fully equipped, with free Wi-Fi throughout the building.

4b (Code) (Expenses \$ 64,413. including grants of \$ 6,196.) (Revenue \$)

Community Development - EVFAC is a hub for all aspects of the Fiber Arts in New Mexico, by creating employment through weaving (Heritage Blankets New Mexico); developing market demand for locally grown and processed fiber by means of EVFAC's Own products; and developing felting and quilting communities to stimulate Fiber Arts activity and economic opportunity for individuals.

Education - Year-round classes in traditional and contemporary fiber techniques with local and national teachers. We aim to help conserve the practice of Northern NM textile arts and foster new directions branching from these traditions. In addition, we offer a hands-on program 'Walk in & Weave' for visitors which allows them within a day's notice and no prior weaving experience to weave a rag-rug, and others that focus on children and youth throughout the year as well as collaborating with Camino de Paz School & Farm for two Summer Camps off-site in June each year.
