The Blood Bank collects, stores and distributes blood products. In addition, the Blood Bank provides the Southern California regions hospitals with a wide range of blood banking services. These include blood collection, component preparation, plateletpheresis, plasmapheresis, leukapheresis, washed blood, frozen blood, autologous storage, designated donation services and a reference laboratory. The Cell Therapy Program of the Blood Bank operates the Cord Blood Program providing lifesaving stem cell transplants to patients worldwide. The Blood Bank acquires blood principally by donation and, to some extent, by purchase from other Blood Centers
