 Recycling Outreach I Love A Clean San Diego operates a call center and two online databases which offer useful information about waste disposal and recycling The organization provides referrals to San Diego County residents who have questions about how or where to recycle or properly dispose of hazardous items These resources divert countless amounts of waste from San Diegos landfills and reduces incidents of illegal dumping ILACSD fielded more than 12,000 requests for recycling information in 2014 from WasteFreeSD org, RepairSD org and 1-800-237-BLUE Additionally, ILACSD provides recycling outreach at community events, educating the public about a variety of topics, including used motor oil recycling, and conducts site visits to used motor oil certified collection centers to ensure compliance
