Job training and career services Goodwill is a leading provider of job training programs and career services in eastern and central Massachusetts These programs help individuals who face barriers to self-sufficiency develop skills, obtain and keep jobs and create more rewarding and independent lives In the year ended June 30, 2015, Goodwill's job training programs enrolled 557 individuals considered hardest to employ in programs offering case management, job skills and readiness training, placement and post-placement services and helped 245 individuals find jobs Boston Career Link, the one-stop career center operated by Goodwill, assisted 7,708 individuals with career services and referrals to training programs, documented 1,025 placements and engaged 127 businesses in 238 on-site recruitment sessions Goodwill's social enterprises provided work experience and a paycheck to 325 individuals in retail, housekeeping and maintenance, and light assembly (The retail program is described in Part III 4b) In addition, Goodwill's Youth Initiative provided a broad range of opportunities to 128 young people to help them achieve in school, graduate from high school, and transition to college or jobs

Retail program The retail program is a social enterprise that benefits the community by providing job training for individuals with barriers to employment, creating jobs, and making quality, low-cost goods available so that individuals, particularly those of limited means, get the items they need at affordable prices In the year ended June 30, 2015, Goodwill's retail program operated 11 Goodwill Stores and collected donations at 31 sites located throughout eastern and central Massachusetts The retail program provided jobs and job training opportunities involved in collecting, sorting, distributing, merchandising, and selling donated clothing and household goods It also provided interview attire and accessories free of charge to 400 job trainees from Goodwill and other community-based job training programs to help them secure jobs, and made clothing and other goods available to local non-profit organizations also serving those in need

The Compensation Committee regularly engages a compensation consultant to compile and evaluate data regarding compensation of similarly qualified individuals in comparable positions at comparable organizations of size and complexity in both the profit and nonprofit sectors. The Compensation Committee evaluates the CEO's performance and makes recommendations for the CEO's compensation to the Board while also monitoring the compensation of the vice presidents to assure that it is in compliance with the program. The Compensation Committee reports its recommendations for approval in executive session. Deliberations and recommendations are documented in writing. The Executive Compensation Policy was followed in setting the compensation for the CEO and vice presidents in the fiscal year ending June 30, 2015.</p>
