In 2015 BtGA constructed two newly designed suspension bridges. One bridge contained steel decking which will become our standard. We also refurbished two bridges in west Pokot and 75% completed a new M type, 45 meter suspension bridge (Peace Bridge). Our Technical Advisory Committee implemented a new bridge design, and our R&D with micro-piles was implemented on two suspension bridge tower foundations. We also implemented our new built-up angle iron towers design on two new bridges. We had a successful fundraiser event, met with MMM Engineering Group in Ontario Canada and were fortunate to have Mammoet Company donate wire rope and safety equipment to our bridge building cause.
