FINANCIAL ASSISTANCE PROGRAM - DURING 2015, THE ORGANIZATION'S MAIN PROGRAM PROVIDED EMERGENCY FINANCIAL ASSISTANCE, HOPE, COMPASSION AND LOVE TO 533 CHILDREN AND FAMILY MEMBERS IMPACTED BY CHILDHOOD CANCER. THE PROGRAM HAS SERVED A TOTAL OF 3,366 INDIVIDUALS SINCE INCEPTION. DURING 2015, 97% OF TOTAL EXPENSES WERE PROGRAM EXPENSES.

THE ORGANIZATION IS COMMITTED TO PROVIDING EMERGENCY FINANCIAL RELIEF TO HELP FAMILIES ENDURING PEDIATRIC CANCER PAY FOR EVERYDAY NECESSITIES SUCH AS MEDICAL, UTILITY, RENT, CAR, GAS AND FOOD. THE ASSISTANCE IS DESCRIBED AS A LIFELINE PREVENTING FAMILIES FROM SPIRALING DOWN AND VITAL TO THE SURVIVAL OF THE CHILDREN IN TREATMENT.

ADVOCACY PROGRAM - GENERATES COMMUNITY SUPPORT TO FURTHER ASSIST FAMILIES WHOSE EXTREME NEEDS EXCEED THE ORGANIZATION'S LIMITED RESOURCES.
