Reel Works programs are designed to engage youth through intensive in-school or after-school filmmaking workshops and to provide a safe community and a continuum of learning opportunities that last throughout high school For our Brooklyn-based programs, most youth enter Reel Works through our 22-week LAB where we guide students through the creative and technical challenges of crafting a narrative and making a short documentary to learning how to bring their stories to audiences The MASTER LAB teaches graduates advanced skills screenwriting, cinematography, editing, production, casting, and directing The SUMMER LAB serves as another portal of entry into Reel Works, engaging students in poetry and video projects REEL WORKS PRODUCTIONS is where Lab graduates make films for actual clients engaging in extraordinary, career-building opportunities and providing Reel Works with a source of earned income REEL FUTURES MEDIA INTERNSHIPS our job readiness/internship program, prepares students for college and beyond to the workforce
