Because of our accountant's maternity leave, in addition to her family crisis, Helping Link filed a Form 990 extension request which extended the due date to November 15, 2016. The graduate student completed the 2015 Form 990 and he and the organization believed he had submitted it electronically by the November 15, 2016 deadline. It wasn't until we tried to access the online tool to work on the 2016 Form 990 that our new accountant and Helping Link became aware that the 2015 Form 990 had not been submitted as we thought. This was a few weeks ago. Since he was submitting the Form 990 electronically, our guess is that our accountant didn't push the final submit button. On discovering that the 2015 Form 990 had not been submitted, we quickly reviewed it and are submitting it now. Throughout this past year, we believed that we had completed and submitted our 2015 Form 990 on time. As soon as we learned, that the 2015 Form 990 somehow had not been submitted, we jumped in to rectify the situation. We appreciate your consideration.
