THE FAMILIES COLLECTIVELY SERVED OVER 21,560 COMMUNITY SERVICE HOURS TO EARN THEIR HOMES, MAKING A HUGE IMPACT IN THEIR COMMUNITIES. THE SAFETY, SECURITY, AND PEACE THAT IS PROVIDED BY ADEQUATE SHELTER ARE FUNDAMENTAL FOR A HEALTHY LIFE.
