Expanding Reach of Annual Freedom Conference Our 7th Annual Freedom Conference & Festival, held in August 2015 in the spectacular Rocky Mountain setting of Steamboat Springs, Colorado, once again attracted a sold-out nationwide audience to hear inspiring speakers such as Dr Ben Carson, Laura Ingraham, Bob Woodson, Pete Coors, Mary Katharine Ham, Guy Benson and many others Approximately 60% of our attendees are from communities all over Colorado and 40% are from outside Colorado C-SPAN televised several of our sessions, and we attracted many new attendees who had never before attended any of our events To accommodate many people, who we previously had to turn away due to space constraints, we added a Freedom Festival Tent to this years Freedom Conference A large percentage of our attendees in the Festival Tent were under age 30 Those who attended were educated on the five core principles (limited taxes, limited government, individual rights and responsibilities, free market capitalism and a strong national defense) and were inspired to return home to their communities all across America and get involved in issues of importance to their communities, their states and our nation Portions of our Freedom Conference were televised by C-Span Videos of all speakers may be viewed at www steamboatinstitute org Expanding Reach of our Speaker Series In 2015, we expanded the reach of our popular Speaker Series by co-hosting two events on the University of Colorado campus in Boulder in partnership with CUs Conservative Thought & Policy Program The speakers for these two events were Yaron Brook of the Ayn Rand Institute, speaking on The Morality of Capitalism, and Jay Nordlinger, Senior Editor of National Review, speaking on his new book, Children of Monsters We also continued to bring conservative thought and policy leaders to our Speakers Series at the Strings Music Pavilion in Steamboat Springs Speakers included an expert panel on the EPAs Clean Power Plan and Peter Wallison, Senior Fellow with the American Enterprise Institute, speaking on the 2008 financial crisis and how it could happen again These events have proven to be extremely effective in keeping citizens engaged and inspired throughout the year Awarding 2nd Annual Tony Blankley Fellowship Through our Tony Blankley Chair fellowship awards, The Steamboat Institute is able to foster the growth of outstanding young journalists This fellowship honors the memory of Tony Blankley and includes a \$10,000 stipend Our Fellows are helping to shape public opinion on the proper role of government, are making persuasive arguments on how conservative principles should shape public policy, and are making the case for why the concept of American Exceptionalism is essential to our freedom In August 2015, we awarded the 2nd annual Tony Blankley Chair for Public Policy & American Exceptionalism to Jillian Melchior, who writes for National Review, and does investigative reporting on domestic issues, including government waste, fraud and abuse, energy and environmental issues, and organized labor She was a Bartley Fellow at The Wall Street Journal Asia Jillian is a frequent guest on Fox Business Network, Fox News Channel and other media outlets The Steamboat Institute was proud to co-sponsor her trip to Eastern Europe in October 2015, where she reported on the refugee/migrant crisis One of her articles on this crisis was published in The Wall Street Journal on October 23, 2015, and we were proud to have Steamboat Institute included in the tagline In addition to awarding the 2nd annual fellowship to Jillian Melchior, the Steamboat Institute recognized Tom Rogans outstanding work and leadership as the inaugural Tony Blankley Fellow by extending his fellowship and naming him Senior Fellow Tom continues to write insightful commentaries on ISIS, the Middle East and other pressing issues of national and international importance His columns are published in National Review, OpportunityLives com, The New York Post and other print and online publications Since he was named our inaugural Blankley Fellow in 2014, Tom has become a regular panelist on The McLaughlin Group, sitting in the chair once occupied by Tony Blankley His many TV appearances on TMG, Fox News Channel and other media outlets prominently feature Steamboat Institute Fellow In October 2015, the Steamboat Institute hosted our 3rd annual cocktail reception and dinner in Washington, D C to raise funds for the Tony Blankley Chair for Public Policy and American Exceptionalism This event was held
