The 2015 five-day/four night camp sessions took place in three locations Western North Carolina (YMCA Camp Harrison in Boomer, NC), near Atlanta, Georgia (Camp Twin Lakes in Rutledge, GA), and near Columbus Ohio (Recreation Unlimited in Ashley, OH) Camps were leased for one-week programs in March, September and October The website is maintained for camper sign-up and for recruitment of volunteers There is extensive planning for camp sessions for adults with developmental disabilities The Georgia camp session was held March 16-20, 2015 and served 53 disabled adults with help from 67 volunteers The Ohio camp session was held September 14-18, 2015 and served 39 disabled adults with help from 72 volunteers The first North Carolina session was cancelled due to high winds and severe weather from Hurricane Joaquin, but was replaced with a Day Camp on November 13th at YMCA Camp Thunderbird (Lake Wylie, SC), and served 40 disabled adults with help from 30 volunteers The second North Carolina session was held October 10-14, 2015 and served 63 disabled adults with help from 72 volunteers
