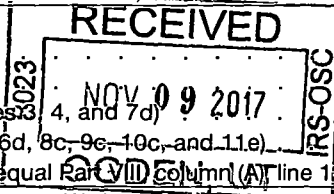

ACCO has served as a primary partner to the U.S. Environmental Protection Agency in co-producing the annual Climate Leadership Conference and Awards program in partnership with The Climate Registry and the Center for Climate and Energy Solutions. The Climate Leadership Awards is a national awards program that recognizes and incentivizes exemplary corporate, organizational, and individual leadership in response to climate change. In February 2012, the first-ever awards were presented to one individual and 20 organizations from across the U.S. who are leading the way in the management and reduction of GHG emissions-both in internal operations and throughout the supply chain. The Climate Leadership Awards Dinner takes place during the annual Climate Leadership Conference. The accounting cycle for this event extends across two fiscal years -- ACCO separated from the Conference subsequent to the February 2015 event. Most expenses for the event were paid in 2015 while a significant portion of revenues were received in FY 2014.

ACCO produced a series of nationally recognized education and training conferences including the 3rd annual Rising Seas Summit (produced in collaboration with the City of Boston and numerous New England regional stakeholders) and the 2nd annual Climate Strategies Forum ("CSF"). While revenues and expenses related to the CSF both are accounted for in FY 2015, the Rising Seas Summit accounting reflects all revenues in 2015 and only in some of the expenses for the event in 2015 due to final billing taking place in 2016. Additionally, some of the expenses from the 2014 Rising Seas Summit fall into accounting in 2015.

The Future Climate Change Officer Fellowship Program (Future CCOs) is designed to connect masters level graduates who have focused their studies upon climate change or sustainability (and have formal education in business, law, engineering, public policy and/or communications) with companies, universities and government entities to work on climate change related response efforts (e.g. supply chain management, GHG management, adaptation and resilience, disclosure and investor relations, etc.).
