The President of the Board of Trustees, in conjunction with the Executive Committee, will also determine the appropriate salary increase for the forthcoming year for the Executive Director and Managing Attorney, taking into account their achievements in the prior year, value to the organization and reasonable comparisons to an appropriate peer group, and will document any increase with the Controller.
