 THE COMMON CAUSE EDUCATION FUND (CCFE) IS A NONPARTISAN ORGANIZATION DEDICATED TO RESTORING THE CORE VALUES OF AMERICAN DEMOCRACY, REINVENTING AN OPEN, HONEST, AND ACCOUNTABLE GOVERNMENT THAT SERVES THE PUBLIC INTEREST, AND EMPOWERING ORDINARY PEOPLE TO MAKE THEIR VOICES HEARD IN THE POLITICAL PROCESS. CCFE EMPLOYS RESEARCH, OUTREACH, EDUCATIONAL PROGRAMMING, AND COALITION BUILDING TO INCREASE PUBLIC UNDERSTANDING OF HOW OUR DEMOCRACY WORKS, EMPOWER CITIZENS TO HOLD THEIR GOVERNMENT ACCOUNTABLE, AND PROMOTE BROAD AND EFFECTIVE CITIZEN ENGAGEMENT AT FEDERAL, STATE, AND LOCAL LEVELS

 VOTING AND ELECTIONS- "DID WE FIX THAT?" IN THE DAYS LEADING UP TO THE ELECTION, RELEASED A COMPREHENSIVE REPORT ON HOW THE RECOMMENDATIONS OF THE PRESIDENTIAL COMMISSION ON ELECTION ADMINISTRATION WERE IMPLEMENTED IN 10 SWING STATES - ELECTION PROTECTION IN PARTNERSHIP WITH ORGANIZATIONS SUCH AS THE LAWYERS' COMMITTEE'S ELECTION PROTECTION COALITION, WORKED TO HELP VOTERS GET THE ACCURATE, NONPARTISAN INFORMATION NEEDED TO CAST THEIR VOTES IN THE 2014 MIDTERM ELECTIONS. RECRUITED AND TRAINED VOLUNTEERS TO SERVE AS POLL MONITORS IN HUNDREDS OF PRECINCTS IN 16 STATES (ESPECIALLY IMPORTANT IN NORTH CAROLINA, TEXAS, WISCONSIN, AND OHIO, ALL OF WHICH SAW MANY LAST-MINUTE CHANGES TO THEIR ELECTORAL PROCEDURES) - THE ELECTION ASSISTANCE COMMISSION (EAC) THANKS TO A RELENTLESS EFFORT LED BY COMMON CAUSE, THE SENATE UNANIMOUSLY CONFIRMED COMMISSIONERS TO FILL THREE OF THE FOUR SEATS ON THE ELECTION ASSISTANCE COMMISSION THE EAC, CREATED IN 2000 TO PREVENT THE SORT OF FLORIDA-STYLE DEBACLE THAT MARRIED THAT YEAR'S PRESIDENTIAL ELECTION, HAS BEEN DORMANT FOR THE PAST FEW YEARS DUE TO THE SENATE'S INABILITY (OR REFUSAL) TO CONFIRM NEW COMMISSIONERS. THE EAC NOW HAS A QUORUM TO APPROVE NEW VOLUNTARY VOTING SYSTEM STANDARDS, WHICH IS CRITICAL FOR STATES AND LOCALITIES THAT NEED TO PURCHASE VOTING MACHINES TO REPLACE THEIR AGING FLEETS. THE EAC ALSO SERVES AS A CLEARINGHOUSE OF ELECTION-RELATED INFORMATION AMONG THE 8,000 JURISDICTIONS RESPONSIBLE FOR RUNNING ELECTIONS - SUPREME COURT CASE ON REDISTRICTING LED THE EFFORT TO ASSEMBLE AND COORDINATE AN AMICUS STRATEGY IN THE ARIZONA INDEPENDENT REDISTRICTING CASE IN WHICH THE ARIZONA STATE LEGISLATURE CHALLENGED THE LEGITIMACY OF ITS INDEPENDENT REDISTRICTING COMMISSION. THE CASE WAS ARGUED BEFORE THE SUPREME COURT IN MARCH 2015. FOURTEEN AMICUS BRIEFS WERE FILED ON BEHALF OF THE AZ-IRC. COMMON CAUSE WAS INSTRUMENTAL IN PULLING TOGETHER A BI-PARTISAN CONGRESSIONAL MEMBERS' BRIEF, AS WELL AS A BI-PARTISAN STATE LEADERS' BRIEF. CALIFORNIA COMMON CAUSE ALSO SUPPORTED A BRIEF WRITTEN BY TED OLSON TO PRESENT CONSERVATIVE VOICES, INCLUDING THREE LIVING REPUBLICAN FORMER GOVERNORS OF CALIFORNIA AND THE CALIFORNIA CHAMBER OF COMMERCE. ON JUNE 29TH, THE SUPREME COURT ANNOUNCED ITS DECISION, AFFIRMING THE RIGHT OF THE PEOPLE TO INNOVATE IN THE STATES TO ADDRESS THE PROBLEM OF GERRYMANDERING. WE COULD NOT HAVE ASKED FOR A BETTER OUTCOME.

 MONEY AND POLITICS - 2015 SUPPLEMENTAL COMPLAINT TO THE IRS RE THE AMERICAN LEGISLATIVE EXCHANGE COUNCIL (ALEC). IN MAY 2015, IN COORDINATION WITH THE CENTER FOR MEDIA AND DEMOCRACY, FILED NEW EVIDENCE TO THE IRS REGARDING ALEC'S CORPORATE LOBBYING ACTIVITIES, AS A SUPPLEMENT TO OUR ORIGINAL 2012 WHISTLEBLOWER COMPLAINT. THE NEW EVIDENCE INCLUDES STATEMENTS FROM 20 PAST AND PRESENT ALEC FUNDERS STATING ALEC ALLOWS THEM TO INFLUENCE LEGISLATION AND GAIN ACCESS TO LAWMAKERS. THE NEW SUBMISSION ALSO INCLUDES A LEGAL ANALYSIS OF ALEC'S NEW 501(C)(4) ORGANIZATION, RECENT ALEC TAX FILINGS, COMMUNICATIONS BETWEEN LEGISLATORS AND ALEC PRIVATE SECTOR MEMBERS, AND A DECISION BY THE MINNESOTA CAMPAIGN FINANCE AND PUBLIC DISCLOSURE BOARD CONCLUDING, AFTER AN IN-DEPTH INVESTIGATION, THAT ALEC'S PRIMARY PURPOSE IS TO INFLUENCE AND PASS LEGISLATION (EVEN THOUGH IT DID NOT TRIGGER THE STATE'S \$50,000 LOBBY REGISTRATION THRESHOLD) - ALEC EXPOSED IN SEPTEMBER 2015, THE COMMON CAUSE EDUCATION FUND SENT A LETTER-CO-SIGNED BY 55 ORGANIZATIONS-ASKING GOOGLE TO FOLLOW THE LEAD OF MICROSOFT AND WITHDRAW ITS MEMBERSHIP IN THE AMERICAN LEGISLATIVE EXCHANGE COUNCIL (ALEC), THE SECRETIVE LOBBYING GROUP THAT PUSHES LEGISLATION IN BEHALF OF CORPORATE INTERESTS WHILE MASQUERADING AS A CHARITY. THE CHAIRMAN OF GOOGLE THEN ANNOUNCED IN A PUBLIC RADIO APPEARANCE THAT GOOGLE WOULD NOT BE RENEWING ITS MEMBERSHIP, CITING ALEC'S DISAVOWAL OF CLIMATE CHANGE. IN THE DAYS THAT FOLLOWED, FACEBOOK, YELP, AND YAHOO FOLLOWED SUIT, ANNOUNCING THAT THEY TOO WOULD BE DISASSOCIATING THEMSELVES FROM ALEC. SINCE THEN, MANY OTHER HIGH-PROFILE COMPANIES HAVE RENOUNCED THEIR MEMBERSHIP, DUE IN NO SMALL PART TO PRESSURE FROM COMMON CAUSE.

 ETHICS, TRANSPARENCY AND ACCOUNTABILITY IN GOVERNMENT- FAST TRACK STATEMENT OF PRINCIPLES. COMMON CAUSE ISSUED A STATEMENT OF PRINCIPLES COMING OUT OF A BOARD-INITIATED TASK FORCE REGARDING "FAST TRACK," THE LEGISLATIVE PROCESS BY WHICH CONGRESS SETS OBJECTIVES AND GUARANTEES THAT ANY TRADE IMPLEMENT LEGISLATION THAT THE PRESIDENT SUBMITS TO CONGRESS WILL RECEIVE A FINAL UP-OR-DOWN VOTE AS PRESENTED, WITHOUT AMENDMENTS - IN THIS CASE WITH REGARDS TO THE TRANS PACIFIC PARTNERSHIP. COMMON CAUSE SHARPENED THE DEBATE WITH RECOMMENDATIONS THAT THE PROCESS BE CHANGED TO ALLOW CITIZENS AND MEMBERS OF CONGRESS ADEQUATE TIME TO AMEND, DEBATE AND MARK-UP THE TPP BILL, BRINGING MORE TRANSPARENCY AND ACCOUNTABILITY TO THE PROCESS - FIX THE SENATE COALITION. FOR FIVE YEARS, COMMON CAUSE HAS BEEN AT THE FOREFRONT OF FILIBUSTER REFORM TO REIN IN SOME OF THE GRIDLOCK AND DYSFUNCTION THAT HAS PARALYZED THE CHAMBER. LATE IN 2013, COMMON CAUSE AND ITS ALLIES IN THE FIX THE SENATE NOW COALITION SCORED A MAJOR WIN WHEN THE SENATE VOTED TO PROHIBIT THE 60-VOTE RULE'S APPLICATION TO MOST NOMINEES. THE HILL CALLED IT ONE OF THE BIGGEST LOBBYING VICTORIES OF 2013. THIS YEAR, AS A RESULT OF THE HISTORIC CHANGE IN ITS FILIBUSTER RULES, THE SENATE PROVIDED UP-OR-DOWN VOTES TO OVER 290 JUDICIAL AND EXECUTIVE BRANCH NOMINEES. MANY OF OUR GOVERNMENT'S IMPORTANT OFFICES NOW HAVE CONFIRMED NOMINEES IN PLACE TO ADMINISTER OUR LAWS, AND OUR COURTS ARE MORE FULLY STAFFED TO PROVIDE ACCESS TO JUSTICE FOR THOUSANDS OF AMERICANS. WE CONTINUE TO WORK WITH OUR PARTNERS IN THE FIX THE SENATE NOW COALITION TO RAISE THE PROFILE OF SENATE OBSTRUCTION AND CALL FOR FURTHER REFORMS TO THE RULES. MEMBERS INCLUDE THE COMMUNICATIONS WORKERS OF AMERICA, THE SIERRA CLUB, THE ALLIANCE FOR JUSTICE, AND THE BRENNAN CENTER.
