IAPF is a development stage organization. A substantial part of IAPF's activities in 2015 focused on developing the organization's infrastructure, donor development and fundraising. Donor development activities included various speaking engagements to educate attendees on IAPF's mission and on wildlife conservation activities in general. Speeches were given to, among other organizations, the Texas A&M University School of Veterinary Medicine, the Jackson Hole Wildlife Film Festival and the New York Explorers Club. IAPF also conducted numerous meetings with individuals and small groups. IAPF conducted multiple fundraising events, including events in Houston, Texas, Southampton, New York and Palm Beach, Florida. IAPF continued to fund its project in the Greater Lebombo Conservancy ("GLC"). The GLC is a conservation area located in Mozambique and covering approximately 750,000 acres. IAPF began conducting anti-poaching operations in the GLC in 2014. Funding in 2015 was directed toward the purchase of vehicles, equipment and construction of an operations center. IAPF also funded salaries for anti-poaching rangers and related staff.
