In the 9½ years of our existence we have raised \$4.3 million in grants and donations and utilized \$6.2 million of in-kind
donation of services and facilities for ramps constructed. These resources funded the start-up and development of 31
regional operations using volunteer labor to construct almost 8,100 ramps at no cost to the recipients. In 2015, volunteers
built 1,623 ramps. Year to year growth has been solid and consistent and is expected to continue through 2016 and beyond.
