GLWN Program - assists in business development and job creation by working with the wind, fuel cell and clean energy supply chain to increase U.S. domestic content in the industry. GLWN provides linkages between wind turbine, fuel cell and clean energy companies seeking to grow in America and manufacturers, suppliers and sub-contractors looking to gain new business. GLWN provides technical assistance to regional, state and national clean energy partners to strengthen the U.S. clean energy industry.

Membership Program - Promotes and implements member-responsive programs and events to meet the needs of the manufacturing community in Northeast Ohio. WIRE-Net connects 380+ organizations through more than 50 networking events and learning opportunities. Businesses learn from peers and industry professionals best practices needed to improve business results through management education and training, find the right resources to overcome barriers to growth, and save on everyday goods and services they utilize. Members are offered services such as talent recruitment, occupational safety consulting, services, supervisory training and networking opportunities. The services encourage competitiveness, job creation, and investment in the communities served by WIRE-Net.

4c (Code:) (Expenses \$ 335,634 including grants of \$) (Revenue \$ 386,919)

Youth Workforce Development Program - provides services to youth in junior high through high school. The program is based at Max S. Hayes Vocational High School, a part of the Cleveland Metropolitan School District (CMSD) and works with the school's staff to provide students employability, life skills, and work based learning which lead to careers in manufacturing, transportation, information technology, building and construction. As part of the Encore Cleveland initiative, the Technical Corps Program (TCP) identifies experienced industry technicians to share their skills and knowledge with the Max Hayes teachers as adjunct faculty, teacher assistants and manufacturing career champions. The program also develops partnerships between community and business leaders and the CMSD administrators and teachers. These partnerships create out of school learning opportunities that mirror industry standards and expectations. WIRE-Net organizes businesses into Technical Advisory Committees, conducts career exploration presentations at elementary schools and community events, supports school-based professional development for faculty, and recruits students and staff to the school.

WIRE-Net in 2015 prepared two case studies of clean energy manufacturers to highlight their support or opposition to proposed

legislation affecting clean energy in Ohio and the US. WIRE-Net also analyzed utility proposals that affect the costs of business for

for Ohio manufacturers. These case studies and position papers were distributed to legislators. WIRE-Net organized a plant tour and policy

roundtables with industry leaders and Federal policy makers to promote the renewal of Federal clean energy tax incentives in the solar and
