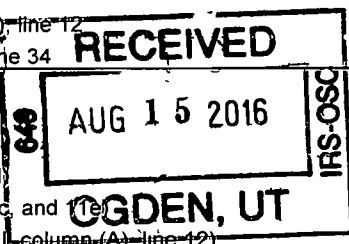

THE ORGANIZATION PROVIDES SERVICES AND PROGRAMS WORKING IN CONCERT WITH THE CITY OF BLOOMINGTON ANIMAL SHELTER, PETSALIVE, LOCAL VETERINARY CLINICS, NATIONAL ADVOCACY ORGANIZATIONS AND OTHER PARTNERS TO IDENTIFY, BUILD RESOURCES, AND CREATE SOLUTIONS FOR ANIMAL WELFARE ISSUES. THROUGH OUR SPAY/NEUTER PROGRAM WE PROVIDED 416 VOUCHERS IN 2015 TO LOW-INCOME PET OWNERS TO HAVE THEIR PET SPAYED OR NEUTERED AT AREA PARTNER VETERINARY CLINICS ACCROSS MONROE COUNTY. IN 2015 MCHA PROVIDED 148 VOUCHERS FOR EMERGENCY MEDICAL ASSISTANCE. IN 2015, MCHA LAUNCHED A MOBILE CLINIC TO PROVIDE LOW COST VACCINATIONS AND MICROCHIPS IN DIFFERENT AREAS AROUND THE COUNTY AND THUS REDUCING THE COST AND BURDEN OF TRANSPORTATION FOR PET OWNERS. THE YEAR WE SAW 195 VACCINE CLINIC CLIENTS.

IN 2015, MCHA PROVIDED OR HOSTED 153 HUMANE EDUCATIONAL PROGRAMS AND 30 COMMUNITY EVENTS WITH AN ESTIMATED REACH OF 5,550 PEOPLE. PROGRAMS INCLUDE ANIMAL AMIBASSADORS AND PAWS AND CLAWS SUMMER YOUTH CAMP THAT SERVE TO INCREASE INTEREST AND EXCITEMENT IN LEARNING ABOUT ANIMALS AND THEIR WELFARE. WE PARTNERED WITH THE MONROE COUNTY PUBLIC LIBRARIES AND BROWN COUNTY LIBRARIES FOR ANIMAL READING FRIENDS WITH MORE THAN 500 CONTACTS ENCOURAGING READING IN THE YOUTH OF THE COMMUNITY.

MCHA COORDINATED 64 SUBSCRIPTION TO "KIND NEWS", A BI-MONTHLY MAGAZINE THAT EMPHASIZES THE KIND TREATMENT FOR ANIMALS WITH MONROE COUNTY PUBLIC ELEMENTARY SCHOOLS.

IN 2015, VIPAWS TEAMS PROVIDED MORE THAN 175 HOURS OF SERVICE AND GRADUATED ONE NEW VIPAWS TEAM. THE TEAMS VISIT AND INTERACT WITH INDIVIDUALS IN RETIREMENT CENTERS, NURSING HOMES, SCHOOLS, AND LIBRARIES ACROSS MONROE COUNTY. EFFECTIVE IN DECEMBER OF 2015, MCHA MOVED TO OWN AND INSURE PRIVATELY THE VIPAWS PROGRAM, RATHER THAN USE A THIRD-PARTY AFFILATE SUCH AS PET PARTNERS. MCHA NOW MAINTAINS REGISTRATION, INSURANCE AND EVALUATION PROCESSES TO BECOME A REGISTERED THERAPY TEAM FOR VIPAWS. VIPAWS TEAMS CAN NOW PARTICIPATE IN ACTIVITIES IN MONROE, OWEN, BROWN, LAWRENCE, GREEN AND OWEN COUNTIES.
