Exhibition Programs The Contemporary Art Museum St Louis (CAM), a non-collecting institution, is internationally recognized for exhibitions of the most provocative, insightful, and urgently relevant contemporary art being made today During fiscal year 2015 (the 2014-2015 season), CAM presented twenty-two exhibitions, featuring prescient and seminal work by emerging and established artists, ranging from painting and sculpture to social practice and participatory art, with two new site-specific installations that transformed the front entrance and courtyard In total, the Museum exhibited 42 local, national, and international artists, and served 30,502 visitors on-site and 143,944 visitors online
