The Step Ahead program operates through a model of individual assistance and aims to take a comprehensive approach to ending poverty. Social workers, lawyers, psychologists, teachers & support staff work together to support over 456 disadvantaged children. In 2015, this support included \$13,711 on nutrition, \$7,196 on the Transition House, \$16,234 on shelter, \$32,873 on long-term support, \$31,190 on social activities such as swimming and roller skating, \$57,428 on emergency support for street children including safe accommodation, clothing, child advocacy and counseling; \$6,157 to support children with disabilities, \$1,697 for early intervention and \$4,550 for learning.

Stay in School
Sponsorship program providing support to children in Bac Ninh Province at high risk of dropping out of school or who have recently quit due to poverty. There are over 800 children in the program. Support includes school fees, bicycles, and medical insurance.

Safe and Sound Program
This is an antitrafficking program in Hue and Dien Bien Provinces. In 2015, Blue Dragon rescued 133 children from forced labor or sexual slavery and obtained legal registration papers for 3325 children. Blue Dragon provides support to former victims who return to school or vocational training, and provides medical assistance and counseling.
