Grantmaker's Description of How Grants are Used	We look at a potential student's financial aid package from the school and use a formula to determine their scholarship eligibility based on the cost of attendance and the amount of money the student has to pay We require all students to make a contribution toward their education of approximately \$4,000 per year, generally financed through loans and work study ScholarMatch then awards a scholarship for the "gap" after the financial aid and the student's contribution, usually an amount ranging from \$500-\$6,000 for the year Once this amount is determined, we send the payment directly to the school with a letter stating that it is to be used for tuition/fees and school related expenses for the student Any remainder, if any, of the scholarship not used by the student is returned to ScholarMatch After the scholarship has been disbursed, ScholarMatch monitors the student's grades and verifies school enrollment ScholarMatch also provides regular phone and email check-ins and additional support as needed for students For students whose scholarships we manage, we follow the disbursement terms of the originating organization
