2015 was a successful year for The Rules /TR. This year, /TR launched frame changing campaign focused on creating a counter-narrative to the Sustainable Development Goals (SDGs) /TR was one of the only critical voices in the civil society or media discourse on this subject. We were the first voice to point out the fact that the SDGs require a 15 times increase in global GDP by 2050 as they are based on a traditional model of growth-at-all-costs and trickle-down economics. The /TR team published 14 opinion pieces, in 10 outlets and another 13 unique blogs on our site. Collectively, these have been shared over 200K times. Tier one journalists and writers such as Nafeez Ahmed (Vice), Zoe Williams (the Guardian) and Charles Eisenstein (Huff Po) wrote feature pieces highlighting the work. /TR has also started to support a global campaign on regenerative farming as a solution to climate change. In September 2015, /TR worked with the Carbon Underground, Organic Consumers Association, Regeneration International and others to launch the meme of "soil is the solution" in the run up to the Pope's address at the Washington Mall. /TR also launched 9x9, an online film festival on food and farming that brought together nine new videos from a director/producer team (the Source Project). The videos were watched by 300K people in about two weeks.
