<p>Clinical Care &amp; Doctor Education - The Alliances AE Clinicians Network remains the premier online resource to identify expert clinicians with experience treating autoimmune encephalitis. This network nearly doubled the number of clinicians during 2015. In March 2015, two of our Board members were invited to attend the Lancet Neurology Conference in Barcelona, Spain where board member Susannah Cahalan presented her story to the hundreds of neurologists in attendance. This was one of many presentations by Susannah to doctors and medical professionals. Finally, Alliance board members continued to engage clinicians who attended the 2014 International Symposium to develop broadly acceptable AE diagnostic criteria.
