MARCH2JUSTICEMARCH2JUSTICE WAS A 9 DAY, 250 MILE MARCH FROM NYC TO WASHINGTON, DC FROM APRIL 13 - 21 TO RAISE AWARENESS FOR THE VICTIMS OF POLICE VIOLENCE, AND TO ADVOCATE FOR SIGNIFICANT CRIMINAL AND RACIAL JUSTICE REFORM INITIATIVES THERE WERE 100 PEOPLE THAT MARCHED THE ENTIRE WAY - THOSE FOLKS, OUR "JUSTICE CHAMPIONS" (JCS) WERE PROVIDED 3 MEALS PER DAY, PLACES TO SLEEP AT NIGHT, TRANSPORTATION BACK TO NYC, PLUS VARIOUS EXTRAS LIKE SLEEPING BAGS AND AIR MATTRESSES, HEALTHY SNACKS THE MARCH ALSO HAD BETWEEN 100 - 2500 'DAILY' MARCHERS WHO JOINED US EACH MORNING AT KICK OFF AND MARCHED FOR JUST ONE DAY ALL OF THE JCS RECEIVED (MANDATORY) NON-VIOLENCE AND DIRECT ACTION TRAINING EVERY NIGHT WE STAYED IN A DIFFERENT TOWN AS THE GUEST OF A CHURCH, MOSQUE, COMMUNITY ORGANIZATION, UNION OR UNIVERSITY EVERY NIGHT WE HAD A TOWN HALL WHERE WE RAISED LOCAL CONCERNS OF IMPACTED YOUTH, AND THE FAMILIES OF VICTIMS OF POLICE BRUTALITY THERE WERE INTENDED (HOPED FOR) CONSEQUENCES/ACCOMPLISHMENTS INCLUDING THE RE-INTRODUCTION OF TWO PIECES OF LEGISLATION IN THE U S HOUSE THAT RELATED TO OUR ISSUES - THE END RACIAL PROFILING ACT WAS RE-INTRODUCED AFTER 12 YEARS, BY REP CONYERS, AND THE STOP MILITARIZING POLICE ACT WAS RE-INTRODUCED BY REP JOHNSON ALSO, THE JJDPA (JUVENILE JUSTICE & DELINQUENCY PREVENTION ACT) WAS RE-AUTHORIZED IN THE HOUSE UNINTENDED ACCOMPLISHMENTS - WHILE MARCHING THRU BALTIMORE THE MORNING OF APRIL 19, FREDDIE GRAY DIED AFTER BEING BRUTALIZED BY POLICE TENSIONS WERE VERY VERY HIGH AND ESCALATING OUTSIDE OF THE POLICE PRECINCT OUR TEAM WAS AT A CHURCH WITH FREDDIE'S RELATIVES, WHEN WE HEARD A SITUATION WAS ESCALATING - WE REROUTED OUR MARCH TO THE PRECINCT, AND A SMALL TEAM OF OUR GANG AND VIOLENCE INTERVENTIONISTS COMPLETELY QUELLED THE VIOLENCE THAT WAS ERUPTING, WHILE STRATEGICALLY USING THE MEDIA THAT WERE FOLLOWING US TO DEMAND ANSWERS ABOUT FREDDIE'S INJURIES AND DETAINMENT AND UNLAWFUL ARREST - FROM THE ASSEMBLED POLICE THE NEXT MORNING OUR MARCH WAS THE COVER STORY OF THE BALTIMORE SUN WITH DETAILS ON THE FREDDIE GRAY CASE AND THE INJUSTICE OF HIS DEATH THAT AFTERNOON THE STATE'S ATTORNEY ANNOUNCED PLANS TO INDICT 6 OFFICERS FOR HIS DEATH ONE OF OUR CORE MEMBERS, FROM BALTIMORE, DECIDED TO STAY THERE HE REMAINED IN THE CITY AND A FEW WEEKS LATER HAD LAUNCHED THE FREDDIE GRAY PROJECT (FGP), A NON-PROFIT ORGANIZATION PROVIDING COMMUNITY JOBS, A COMMUNITY GARDEN AND OTHER ENTREPREUNERIAL OPPORTUNITIES, WHILE FOCUSING ON VIOLENCE REDUCTION THE GATHERING HAS PROVIDED TRAINING AND OTHER RESOURCES TO FGP FOR THE LAST YEAR THERE ARE NUMEROUS STORIES OF OTHERS WHO MARCHED WITH US - THE OVERWHELMING MAJORITY FOR WHOM THAT WAS THEIR FIRST EXPERIENCE OF CIVIL DISOBEDIENCE OR PROTEST OR DEMONSTRATION - WERE COMPELLED TO LEAVE THEIR JOBS FOR WORK IN THE COMMUNITY, AND WE WERE ABLE TO CONNECT YOUTH WHO MARCHED WITH US FROM IMPACTED COMMUNITIES TO LOCAL SERVICES BY ACTIVATING OUR NETWORKS IN EACH CITY/TOWN WE STAYED IN (NEWARK, PHILADEPHIA, BALTIMORE, LINCOLN UNIVERSITY, ETC)

JUSTICE LEAGUE NYCJUSTICE LEAGUE NYC IS AN URGENT RESPONSE TASK FORCE MADE UP OF INDIVIDUALS (VOLUNTEERS) WHO ARE LEADERS OF ORGANIZATIONS OR MOVEMENTS RELATED TO CRIMINAL JUSTICE, RACIAL JUSTICE AND OTHER INTERSECTIONAL MOVEMENTS, WHO COME TOGETHER TO BUILD COLLECTIVE POWER TOWARDS THE MUTUAL GOAL OF THE LIBERATION OF BLACK AND BROWN PEOPLE THIS MISSION FITS UNDER THE OVERALL MISSION OF THE GATHERING FOR JUSTICE WHILE M2J (DESCRIBED ABOVE) WAS THE LARGEST INITIATIVE/EVENT OF JUSTICE LEAGUE IN 2015, THAT KIND OF LARGE SCALE ORGANIZING IS NOT ALL THAT JUSTICE LEAGUE DOES ON THE HEELS OF A TUMULTUOUS END OF 2014 FOR MANY IN THE RACIAL EQUITY/POLICE ACCOUNTABILITY/CRIMINAL AND SOCIAL JUSTICE REFORM MOVEMENTS - JUSTICE LEAGUE HAD ESTABLISHED ITSELF AS ONE OF THE UNOFFICIAL LEADERS OF THE POLICE ACCOUNTABILITY MOVEMENT IN NYC WE ORGANIZED PROTESTS STRATEGICALLY - INCLUDING PRODUCING "I CAN'T BREATHE" TEE SHIRTS THAT WE GAVE TO THE BROOKLYN NETS AND JAY Z WHO WORE THEM ON THE COURT WITH THE ROYAL FAMILY ATTENDING THE GAME - GARNERING INTERNATIONAL ATTENTION FOR THE INJUSTICE OF THE ERIC GARNER STORY WE TOOK THAT ATTENTION AND PUBLISHED A LIST OF CRIMINAL JUSTICE REFORM 'DEMANDS AND BROUGHT TOGETHER A "FAMILY COALITION" OF MORE THAN 70 ORGANIZATIONS - INCLUDING COMMUNITY ORGANIZATIONS, CLERGY AND FAITH LEADERS, YOUTH, ARTISTS, ACTIVISTS, FORMERLY INCARCERATED INDIVIDUALS, FAMILY MEMBERS OF VICTIMS OF POLICE VIOLENCE AND OTHER REFORMERS - TO SET AN AGENDA FOR NY CITY AND STATE TO SUPPORT INITIATIVES THAT IMPACTED POOR AND MARGINALIZED COMMUNITIES WE LED A MARCH ON MARTIN LUTHER KING DAY 2015 TO THE UNITED NATIONS, AND HELD A RALLY THERE TO RAISE AWARENESS ON OUR ISSUES WE ALSO ORGANIZED AND SUPPORTED SEVERAL YOUTH EVENTS IN BALTIMORE AND NYC THAT INCLUDED YOUTH CONCERTS AND SCHOOL BAG AND SCHOOL SUPPLIES GIVEAWAYS - SUPPLIES DONATED BY THE COMMUNITY BECAUSE OUR LEADERS HAVE LARGE MEDIA PRESENCE AND NETWORKS ON THEIR OWN - THEY UTILIZE THEIR PLATFORMS TO ELEVATE IMPORTANT ISSUES AND CASES - LIKE BRINGING THE MOTHERS OF CHILDREN KILLED BY POLICE TO NATIONAL PLATFORMS WITH PRESS CONFERENCES, PUBLIC VIGILS, AND DEMONSTRATIONS THE MAJORITY OF OUR WORK REVOLVES AROUND STRATEGIZING HOW TO USE NON FINANCIAL RESOURCES TO BUILD COALITIONS PROTESTING IS ONE OF OUR TACTICS
