We partner with local Ministries of Health to provide expert health programming and local health care worker training in the areas of noncommunicable diseases, infectious diseases, women's and children's health, and health systems strengthening. In 2015, Project HOPE global health programs helped train 23,717 health care workers and our programs impacted the health of 941,928 individuals

 Humanitarian Assistance The mission of Project HOPE's Humanitarian Assistance is twofold, provide emergency assistance where disasters strike and strengthen developing or weakened health systems with donations of needed medicines and medical supplies. Our team of logistics specialists, pharmacists and medical doctors work with local health officials to select the most urgently needed medicines and supplies. The HOPE supply chain management team handles the receipt, warehousing, and distribution of these donated commodities using state-of-the-art technology and systems. Project HOPE is well known for its stringent monitoring and reporting guidelines, receiving high marks in this regard from donor and funding agencies like the U.S. State Department and PQMD. In 2015, Project HOPE delivered \$223 million worth of donated medicines and medical supplies around the globe

Overall, the Committee follows standard protocols and intermediate sanctions guidelines which include the three procedural requirements for earning the presumption of reasonableness: 1 Compensation actions are approved in advance by the Management Development and Compensation committee members, none of whom have a conflict of interest with respect to the proposed actions. 2 The board or committee obtains or relies upon appropriate data as the comparability of the compensation or fair market value of the consideration, and 3 The committee documents the basis for its determination adequately and contemporaneously.
