For over 43 years, the Living Arts & Science Center (LASC) has provided year-round creative and educational programs and services in the arts and sciences. Located in the inner-city of downtown Lexington, Kentucky the LASC is located in a historic building, the Kinkead House, which was built in 1847 by Abraham Lincoln's attorney, George Kinkead. In 1970, descendants of the Kinkeads' loaned the house to the LASC to use for programs and in 1981, the Kinkead family donated the building and grounds to the organization.

LASC will be opening the Lucille Caudill Little Discovery Center, a 11,000 square foot addition to the historic Kinkead House in 2016. The new facility will include a permanent planetarium, a teaching kitchen, a digital art studio, a recording See Form 990, Page 2, Part III, Line 4a (continued)
