To provide a place in perpetuity where people with disabilities can be successful, equal and capable, growing to their maximum life's potential through interaction with horses in a positive environment. We accomplish our mission by providing recreational, educational, and sport programming, including vocational/prevocational opportunities, to youth at risk and persons with disabilities. Individuals are accepted without regard to race, religion, ethnicity, or socioeconomic background.

Teaching people with disabilities to ride and care for horses, preparing them to show at the Top Hands Horse Show. In 2015, 57 of the possible program days had to be cancelled mostly due to weather. Operating only 47% of the possible days we provided 267 lessons to 44 riders with disabilities. A team of 19 riders participated in the Top Hands Horse Show (HLS&R) earning 6 first place belt buckles, 10 second, 7 third, 6 fourth, 7 fifth, and 5 sixth place trophies, and 7 honorable mention rosettes.

4b (Code:) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 0)

Providing adjudicated youth with the opportunity to serve their assigned community service hours. This included teaching them to use a garden rake, shovel, clean and repair the facility. Seven youth and 1 adult completed 79.46 hours of community service. They removed vines and grass from our fence line, weeded around and under our ramps, washed and waxed our horse trailers and truck. Upon completion of the program they have a better understanding of how to stay out of trouble.

Utilizing volunteers to feed and care for our horses, instruct our people with disabilities, supervise adjudicated youth, maintain the facility, and complete all administrative and fundraising work. A total of 94 volunteers (including the adjudicated youth and adult) gave a total of 3,080 hours to operate Dream Catcher Stables program. This does NOT include administrative or fundraising work. Of the totals given we had 32 very dedicated volunteers who gave 2,695 of the total hours to our program. Formal records of volunteer hours date back to 2004. Cumulative statistics indicate there have been 825 volunteers (including adjudicated youth). Two hundred thirty four of those volunteered at least two years and 36 volunteered 5 years or more. Many of our volunteers are high school students who leave us when they go on to college. While in our program they learn how to effectively interact and work with people with disabilities AND learn to capabilities of our athletes.
