 Community Trails - In FY15, GVLTS Community Trails Program continued with its mission to connect people, communities, and the land through collaborative trail projects In our 25-year history, GVLTL has helped create over 80 miles of trail This year we secured a permanent trail easement on the popular Triple Tree trail, gave the Sourdough Canyon Trailhead to the US Forest Service for long-term stewardship, constructed mile of new trail at Snowfill Recreation Area, installed over 500 trail totem wayfinding signs, and launched a Trail Ambassador partnership to coordinate volunteer trail ambassadors for education and outreach with the trail using public

 Land Conservation GVLTL furthered its mission to conserve working farms and ranches, wildlife habitat, and river corridors in the Gallatin Valley in FY15 We collaborated with four families to conserve 471 acres of land in Gallatin County These projects included over 1.6 miles of the East Gallatin and Madison Rivers, over 290 acres of prime agricultural land, and over 150 acres of critical wildlife habitat This brings our total conserved land to over 43,000 acres in 94 conservation easements We annually visit each of these conservation easements and interview the landowners, providing stewardship support and monitoring to those properties GVLTL was also the lead partner in securing an allocation of \$3.8 million in funding to the Gallatin Valley for land conservation and stewardship projects through the Natural Resource Conservation Services Regional Conservation Partnership Program We continued with outreach to landowners in our priority focus areas, providing information about conservation options and assisting landowners with cost-share funding when possible In FY15, we also assisted with several stewardship enhancement projects on the ground, worth a total of over \$36,000

 Education - GVLTL provided 28 community presentations and participated in seven community events reaching over 2,100 people Our monthly email newsletter reached more than 2,300 community members The GVLTL website is updated monthly with current news relating to community trails, private land conservation and events open to the public Our website also hosts a transparency section with our Audit, annual report, and Form 990 We are active on social media and engage over 2,000 followers on Facebook, 1,300 on Twitter, and hundreds on Instagram We had 750 volunteers who gave over 2,800 hours for the organization in the year, and all volunteers are educated about the mission and accomplishments of GVLTL during their service For the first year ever, we hosted guided group walks on the Main Street to the Mountains trail system Over 260 people attended our 38 walks to learn about GVLTL, the trails, and interesting topics like wildflowers, birds, yoga and more
