An exciting milestone for GJEP was the opening of the Buen Vivir Gallery in our office space last October. The gallery showcased its first exhibit in October, Climate Change Faces, Places, and Protest about the global climate justice movement and communities suffering the impacts of climate change. Our collaboration with the Sojourner Truth on KPFC Pacifica Radio Los Angeles continues with weekly Earth Minute reports and weekly Earth Watch interviews that we organize to help grassroots activists raise awareness about their issues

Highlights of our work to halt the socially and ecologically destructive genetic engineering of trees include the first Indigenous Peoples Action Camp on GE Trees, organized by Indigenous Environmental Network, a member of the Campaign to STOP GE Trees Steering Committee which we attended and presented at. We also organized a series of demonstrations at Brazilian embassies and consulates on five continents against the legalization of GE eucalyptus in Brazil. More than 100,000 signatures were collected to demand the Brazil government not approve the commercial release of GE eucalyptus trees there. In November, GJEP traveled to Paraguay for an international strategy meeting on GE trees we jointly organized with Global Forest Coalition. Our work in the US included legal research, grassroots mobilizing and training, especially focused on the Southeastern US and the Pacific Northwest, where GE tree research and development is most

Biofuelwatch BFW continues to travel to UN Biodiversity Conventions and UN Climate Conventions to warn countries of the social and ecological dangers of wood-based bioenergy. This includes meeting with country delegates, organizing educational side events and press conferences, making statements to the UN plenary and writing reports to distribute to delegates, media and allied organizations. As part of this effort, BFW traveled to Pyeongchang, Republic of Korea in October 2014 and met delegates from 25 different countries. In November, BFW traveled to Paraguay for an international strategy meeting on wood-based bioenergy jointly organized with Global Forest Coalition. Part of this meeting involved preparations for activities at the UN Climate Conference in Lima, Peru which BFW attended in December, 2014
