AFTER THIRTEEN YEARS OF RESCUING AND TRANSPORTING MORE THAN 7,000 ANIMALS, THE ORGANIZATION OPENED THE HART ANIMAL CENTER, WHICH INCLUDES A FULL-SERVICE VETERINARY CLINIC THAT PROVIDES LOW-COST AND NO-COST SPAY/NEUTER SURGERIES FOR LOW-INCOME CLIENTS, AS WELL AS COMPLETE VETERINARY SERVICES. DURING 2015, 1142 CATS AND DOGS WERE SPAYED OR NEUTERED FOR LOW-INCOME CLIENTS.

DURING 2015, HART RESCUED AND TRANSPORTED 208 DOGS AND 271 CATS (INCLUDING PUPPIES AND KITTENS) FROM THE COUNTY SHELTER. THE ORGANIZATION TESTED, VACCINATED AND DEWORMED ALL ANIMALS ARRIVING AT THE COUNTY SHELTER TO PREVENT OUTBREAKS OF INFECTIOUS DISEASES. THE MEDICATIONS AND VACCINES COST \$5,900. THE ORGANIZATION ALSO PROVIDES MEDICAL EXAMS FOR ALL RESCUED CATS AND DOGS.
