Comprehensive Day program services for blind and visually impaired adults through DES Rehabilitation Services Administration Services include Orientation and Mobility training for independent travel, Home management training Braille, Access Technology, individual counseling, support groups, and blindness specific class to support a student in orienting to vision loss, Career Exploration Job Readiness, and Job placement/retention, GED preparation, English as a Second Language, Health and Wellness, In this period, these comprehensive services were provided for, fifty-three (53) in Phoenix, thirty-nine (39) in Tucson, AZ and thirteen (13) in Yuma, AZ Academic Supported Education services for twenty-seven (27) blind and visually impaired college students in Tucson, one (1) in Yuma and twenty-nine (29) in Phoenix BEP - Business Enterprise Program was kicked off this fiscal year as an extension of Supported Education and Job Training. Three (3) individuals participated in the program and engaged in training with the vision to manage vending and dining within the Business Enterprise Program Adult Residential Services for eight (8) blind vocational rehabilitation students Residential Program for Twenty (20) blind and visually impaired individuals transitioning out of high school (Steppin Out Program) Six week Summer Residential Camp (Ready Set Go Youth!) for thirty-two (32) teenage students in July 2014 and thirty-two (32) in June 2015 for blind and visually impaired High School Transitional Youth ages fourteen to twenty years old Educational Core Competency Program for Blind children services included, two week Summer Day Camp (NFB Bell Program) for twenty (20) blind and visually impaired children ages five to twelve years old, Weekend programming events for blind and visually impaired youth ages K to 12th grade, attendance 83 students, 49 parents with 60 hours of activities including daily living instruction, communication skills, orientation and mobility and other social and enrichment activities, Family Retreat conducted in January 2015 at Triangle Y Ranch camp 13 blind children with 14 of their siblings and 18 parents participated in 50 hours of programming for the overnight event Transportation program received seven (7) new vehicles as part of the Federal Transit Program to be used throughout the state to provide transportation for students and blind staff Program provided 10,200+ rides for blind and visually impaired individuals with transportation and 269,539 miles were driven Provided Independent Living services statewide for an average of 46 individuals per month who are blind or visually impaired, 85% of who are Seniors over the age of 65 Provided Day treatment activities for nineteen (19) developmentally disabled individuals who were also blind and visually impaired which included 1,736 hours of programming, delivering 28,176 units of service through a contract with Arizona Division of Developmental Disabilities Phoenix childrens Adaptive Sports program conducted 6 events for blind children of all ages The program served 29 students and 16 family members with 16 hours of direct activities between January and June including, introduction to Goal Ball (Olympic event), indoor rock climbing, Beep baseball, karate and martial arts classes and a hiking/biking event
