The Liberty Theater presents current and classic movies, produces live community theater dramatic and musical shows, and hosts additional youth theater activities and civic events throughout the year.

Film/Cinema Presentations:

Our movie/cinema presentations were very successful, showing more than 48 first-run, children's, and classic movies this year. Community residents in our remote and rural community in Eastern Washington, appreciate and enjoy the movies presented. We maintained reasonable and reduced admission prices to make it affordable for many who would not otherwise be able to enjoy this kind of recreational activity. Most of our films are intended for general family viewing with popular matinee showings. Special film showings accompany seasonal fundraising events for holidays and other seasonal activities.

4b (Code:) (Expenses \$ 20,312 including grants of \$ 1,900) (Revenue \$ 41,999)
Live Theater Productions:

Our organization presented live theater productions throughout the year. Our Fall Musical involved more than 70 volunteer community actors, singers, stage hands, directors, parents, and others who devoted more than 3,500 hours of volunteer time to make the production a success. More than 1,400 theatergoers attend 10 showdates during November and December 2014. Our Spring Variety Show also involved many local performers from the community and played to sell-out crowds during March 2015. Again this year, as we have for the past 12 years, we presented a week-long youth theater workshop and performances by the Missoula Children's Theater involving more than 45 children from 6 to 18 years of age and played to sell-out crowds. All of these live shows are attended by local community members and guests who often travel more than 100 miles to see our shows. We often exchange theater props and costumes with other community theaters in the area, or rent them at reduced rates.

Educational and Community Forum:

Our theater also functions as a community forum for events put on by other local groups and institutions such as, the Candidate's Forum sponsored by the League of Women Voters, a staff leadership training by our local hospital district, and youth organizations. We often waive the rental or charge a nominal fee for use of the facility to defray costs for other community organizations. Our theater lobby displays a continuing rotation of artwork of local artists to display their paintings and sculpture to the community.

SECTION VI, A2: Directors Greg Skiffington and Cheryl Skiffington are each other's spouses.

SECTION VI, A7a: Board members are elected by current board members upon expressing an interest in participating in board activities.

SECTION VI, B11b: The 990 report is reviewed by a standing Finance Committee and made available to the public.

SECTION VI, B12c: Our conflict of interest policy is reviewed and monitored at any board meeting where potential conflicts arise.

SECTION VI, B15a & b: Our Executive Committee directly supervises key personnel and determines salaries based on comparability data.

SECTION VI, C19: All of our policies are made available to the public upon request at our administrative (and only) office.

SECTION III, 4d: Other program expenses are funded in large part by income from fundraisers and other donations.

SECTION III, 3b: ALL Unrelated Business Income was exempt. All of the activity (development of on-screen advertising) was conducted by volunteers. The activity is somewhat related to our exempt purpose, but to ensure it remained exempt from UBIT, volunteers did all the work.
