CCIH provides permanent supportive housing and professional support services to 27 formerly homeless families impacted by disabilities at Garden Park Apartments in Pleasant Hill. CCIH offers youth enrichment programs, case management, and other support services to an additional 247 at-risk families living at 3 affordable housing programs located in central and east Contra Costa County. CCIH also has a housing advocacy program for residents diagnosed with HIV disease who live in east and central Contra Costa. In total, CCIH offers housing and/or services to over 860 poverty-impacted individuals in east and central Contra Costa.

CCIH provides permanent, affordable housing and on-site support services to formerly homeless and at-risk families and individuals with special needs. Supportive service programs assist families and individuals to stabilize in housing and improve self-reliance. CCIH offers services on-site to residents in its programs including intensive case management, youth afterschool academic tutoring and enrichment, parenting and employment skill development, and mental health services. During the period covered, 862 clients were served.

CCIH provides housing advocacy services for Contra Costa County residents diagnosed with HIV disease. Advocacy includes emergency housing and rental assistance, ongoing monitoring of medical care, case management support and care coordination. During the period covered 149 clients were served.
