In 2015, Art With Elders taught classes in over two dozen facilities in the Bay Area. Our organization was founded to visit seniors in nursing homes, but soon found that a more meaningful way to spend time with them was to do something with them, and this led to art classes. It has been amazing to see the changes that can happen from engaging in creative work. Recent studies have shown that older adults who engage in art classes are 74% less likely to develop cognitive decline.
