National program expenditures funded our national campaigns and programs, from organizational support for state affiliates, to policy advocacy, to national educational campaigns A few highlights were our national conference of state affiliates in Washington, our response to Pope Francis's encyclical on the environment, and a major focus on signing up congregations and houses of worship to take the "Paris Pledge" in advance of the Paris C O P 21 (the international conference on global warming) Those taking the pledge committed to cut their carbon footprint in half by 2030 and to be carbon neutral by 2050 Over 2015 IPL generated significant media coverage and increased our social media presence We reached out to over 74,000 people on our email list, and 18,000 congregations
