Social Services An estimated 25,000 LGBT seniors live in San Francisco Research is clear that LGBT seniors are less likely to participate in general community activities and access the housing and services they need because they fear judgment, rejection or compromised care Thus, LGBT seniors either do not disclose their sexual orientation or gender identity or at risk to their health and well-being remain isolated without access to housing and community-based services Openhouse increases access to housing, health and community services by providing the support services (See Schedule O for full details) The agency served 1,860 individuals in FY15

Housing Openhouse is building housing that is welcoming to LGBT Seniors with on-site, culturally sensitive services that promote health, well-being and independence -In 2011, Openhouse formed a partnership with Mercy Housing California, a highly experienced nonprofit developer of affordable housing, and secured significant funding from the City and County of San Francisco to develop a new housing community welcoming to LGBT seniors at 55 Laguna Street in San Francisco -Phase 1 of the development began in April 2015 with the renovation of Richardson Hall When completed in September 2016, the historic building will include 40 apartments, a ground floor retail space and an expanded Openhouse Information and Service Center

Phase 2, scheduled to begin in October 2016, includes 79 additional units of housing and a new Openhouse Program Center -Separately financed through a community fundraising campaign, the expanded Openhouse facilities along Laguna Street will accommodate the delivery of multiple support services and a wide range of resource events, educational programming, and community-engagement opportunities for both residents and LGBT seniors living across the city

Openhouse Programs and Accomplishments	<p>Openhouse is a charitable organization, founded in 1998 to enable San Francisco Bay Area lesbian, gay, bisexual and transgender (LGBT) seniors to overcome the unique challenges they face as they age. The Organization provides housing, direct services, and community programs that reduce isolation and empower LGBT seniors to improve their overall health, well-being, and economic security. Without children or other biological family to rely on, LGBT older adults need a model for aging in a community tailored to their lives and family structures. The Organization's goal is for every LGBT senior to live in safe and stable housing that is affordable to them, be welcomed and appropriately served by all providers along the continuum of care, and be engaged with and supported by their communities of choice. Housing For decades, thousands of LGBT people have flocked to San Francisco to find personal freedom and acceptance. As older adults, many LGBT seniors struggle to find housing they can afford where they also feel safe to live authentically in a community that respects their lives and understands their relationships. In 2011, Openhouse (through its wholly-owned subsidiary, Openhouse Laguna LLC (the LLC)) formed a partnership with Mercy Housing California, a highly experienced nonprofit developer of affordable housing. Through the 55 Laguna LP (the LP), the two agencies secured significant funding from the City and County of San Francisco to develop a new housing community welcoming to LGBT seniors at 55 Laguna Street in San Francisco. Phase 1 of the development began in April 2015 with the renovation of Richardson Hall. When completed in September 2016, the historic building will include 40 apartments, a ground floor retail space and an expanded Openhouse Information and Service Center. Phase 2, scheduled to begin in October 2016, includes 79 additional units of housing and a new Openhouse Program Center. Separately financed through a community fundraising campaign, the expanded Openhouse facilities along Laguna Street will accommodate the delivery of multiple support services and a wide range of resource events, educational programming, and community-engagement opportunities for both residents and LGBT seniors living across the city. Social Services Healthy Aging Planning and Support An estimated 25,000 LGBT seniors live in San Francisco. Research is clear that LGBT seniors are less likely to participate in general community activities and access the housing and services they need because they fear judgment, rejection or compromised care. Thus, LGBT seniors either do not disclose their sexual orientation or gender identity or at risk to their health and well-being remain isolated without access to housing and community-based services. Openhouse increases access to housing, health and community services by providing the following support services. The agency served 1,860 individuals in FY 15. Information and Assistance LGBT older adults find new sources of support and access critically needed services through the information, referrals and basic emotional support provided by Openhouse. To meet growing community demand and the priorities identified by the San Francisco (LGBT) Aging Policy Task Force, Openhouse was designated as one of ten city-funded Aging and Disability Resource Centers in July 2014. Case Management and Care Coordination In September 2014 Openhouse began the city's first case management program for LGBT older adults who have multiple challenges and more complex needs. This continuum of assistance provides the wrap-around support, linkages and coordination that all seniors need. For LGBT seniors, the vast majority of whom do not have children, these services are critical to maintain their independence and ability to remain living in a community setting. Housing Assistance Openhouse is a critical source of information when new and existing affordable housing options become available. At weekly housing workshops, seniors receive information about their options and eligibility requirements. In follow-up sessions, staff and peer-to-peer volunteers assist individuals to complete applications and improve their chances of success through financial coaching, debt management, and budgeting. Over the last 5 years, Openhouse has provided housing-assistance to almost 1,000 LGBT seniors. Of the approximately 500 who were actively seeking housing, Openhouse helped 326 people find housing and/or get placed on wait-lists for future openings. Friendly Visitor Program Openhouse recruits, screens and trains hundreds of volunteers to provide ongoing companionship, emotional support and practical assistance to LGBT adults at risk for social isolation. Friendly Visitors help reduce this risk by helping seniors socialize and maintain support networks, which is directly correlated to reducing hospitalization stays, avoiding institutional care and improvements in health. Community Engagement, Health and Wellness LGBT seniors rely on friends, community members and organizations like Openhouse as their chosen family to stay engaged and stay healthy. Community Engagement Programs Community Engagement programs bring LGBT seniors together to reduce social isolation, stay engaged, enrich their lives and have fun. Social and cultural activities include self-directed social events like game days and monthly potlucks, movie screenings, museum tours and other outings, general discussion groups, and arts and writing workshops. Over the next year, LGBT seniors will enjoy more opportunities for civic engagement and a life enrichment program with evening classes led by volunteer educators and experts in particular areas of interest. New targeted activities will focus on the interests of particular community segments, including members of the community who identify as transgender and people of color. Health and Wellness Activities To reduce health disparities, promote healthy behavior and encourage early access to care, Openhouse offers 50 health and wellness workshops led by health professionals each year. Workshop topics include HIV/AIDS prevention and treatment, diabetes prevention, healthy eating, managing stress, reducing suicide ideation, and reducing high blood pressure. In addition to these workshops, Openhouse offers weekly exercise classes, meditation program, and support groups (including an HIV/AIDS support group). Training and Partnership Building The Openhouse Cultural Sensitivity Training and Technical Assistance program is a critical component of our strategy to create physical, emotional and economic stability for LGBT seniors who receive services across the greater housing and senior-services sector. Our training program effectively empowers partner agencies that serve seniors to break down the barriers LGBT seniors face in accessing their housing and services. In addition to building a network of trained agencies that is welcoming and able to serve LGBT seniors over-time, the program expands options for our clients today.</p>
