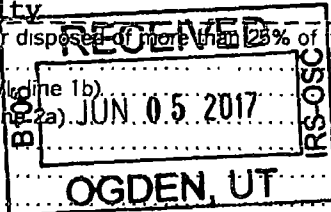

Family Camp: YES provided weekend-long Family Camps for 390 low-income, underserved Richmond residents through five Family Camps. Four camps were provided for families associated with two specific schools in Richmond, and one was designed to focus especially on leadership development for teen and adult participants and their families. YES engaged an average of 25 volunteers during each weekend to support programming. Youth participants engaged in an average of 520 minutes of physical activity, and adults in an average of 360 minutes of physical activity each weekend. 94% of participants expressed an intention to continue their physical activity after Family Camp.

YES launched Camp Days which enhanced our regular Summer Camp programming and broader Youth Pathway. The outings took place over 5 days in winter/spring 2016 and served a total of 173 youth.

Summer Camp: YES provided scholarships for 329 Richmond and West Contra Costa County low-income youth ages 8-17 to attend week long residential summer camps, and supported 31 youth, ages 14-17, to obtain leadership positions at summer camp. The total amount raised in scholarships was \$75,275. For the program period YES provided outreach, application support, translation services, financial support, transportation support, and orientation for both children and families and camp staff. The program also provided 173 youth with additional outdoor experiences via day outings known as "Camp Days" in local open spaces near to their homes during the academic year. Through facilitated experiences in nature, the Summer Camp program supports low-income, underserved youth to gain exposure to the outdoors where they build self-confidence, develop social and leadership skills, and form new friendships with peers and positive adult role models.

Form 990, Part III, Line 4b - Program Service Accomplishments

Camp-to-Community: YES increased the number of actively engaged teens in the Camp-to-Community (C2C) program from 30 to 36 teens, and expanded program offerings. During the two prior fiscal years, YES engaged 30 teens through this program and sustained a significant increase in participation during FY2015-16. For the first time, a selection of actively engaged teens participated in a multi-week wilderness or social justice intensive summer program. C2C also provided all teens with an average of 19 days of nature immersion programming, both day-long and multi-day experiences, which included leadership development training and service learning.

An additional 11 teens participated in a year-long youth participatory action research cohort that involved extensive civic engagement and presentations in the community.

Wellness: YES's Wellness Program brings together adult leaders from the schools and communities that YES serves to participate in health and wellness activities and education. Through Wellness workshops and training, YES staff recruit and train a diverse group of multicultural Wellness navigators who serve as peer educators across a variety of health and wellness topics including non-defensive communication, safety, nutrition, and physical activity. During the year ended August 31, 2016, YES staff worked with a core group of 20. Wellness navigators from Central and North Richmond.

YES's Day Outing program brings together Richmond community members for the annual Walk to Nature event. The purpose of the walk is to promote physical activity, good health and to connect with our community in nature. The origin of the walk comes from several day outings that YES and partner, East Bay Regional Park District, have conducted over the years to introduce Richmond families to nearby regional parks in Richmond that can be accessed easily and affordably. 345 people attended the walk in August 2016.
