The Rockland County YMCA is able to accomplish its mission through 25 program sites and member services at its main building in Nyack YOUTH DEVELOPMENT - The Early Childhood Programs provide affordable child care for over 83 children at Ys Beginnings Pre-School in Suffern, and the Ys Beginnings Pre-School Program in Sloatsburg. The School Age Child Care Department operates before and after school child care programs in 15 sites. The program served 909 children in 4 school districts including Clarkstown, Ramapo Central, South Orangetown, and Nyack. The Fun Club held on school breaks served 90 children. It also offered a summer program for 48 youth at its main building in Nyack. North Rockland Program Department operates an extended day Kindergarten program pre K and before and after school child care programs at 5 schools for 243 children in the K-7th grade in the North Rockland Central School District. The Schools Out program at Camp Bullowa served 88 children. A summer camp was operated in Pomona which served 164 campers from K-6th grade. The Youth Department operates a summer teen program for 31 teens and separate Girls and Boys Mentoring Programs for 22 teens. The Youth and Government Program had 65 teens participate in a legislative and judicial program to develop leadership skills, public speaking and promote good citizenship in cooperation with local high schools. The Dance Department provides creative movement and dance classes for 214 youth to develop coordination and self-confidence. There are 660 children who are learning to swim at the YMCA progressive swim program. Fitness programs for 225 youth and teens include soccer, basketball, tennis, fencing and karate which develop skills and promote team work. HEALTHY LIVING - The Aquatics Department provides a variety of programs including water exercise classes for older adults and those with disabilities, lifeguard training and swimming lessons. There are 179 adults who are participating in swim lessons or life guard certification courses. The Fitness Department provides instruction on using strength and cardiovascular equipment and offers health enhancement classes for adults and seniors to promote physical fitness and well being. Programs for adults also include fitness classes and dodge and volley ball. SOCIAL RESPONSIBILITY- The YMCA operates the Childrens Center at the Family Court in New City, which served 819 children and 565 families during the 2016 year. Due to confidentiality they are not included as annual members or program participants. The North Rockland Community Partnership Program sponsored by a grant from the United Way had a positive impact on 509 people. There were 157 adults and 32 teens who took part in strengthening families and parenting sessions at the Haverstraw Center. There were 78 teens who took part in life skills classes and after school physical education and sports activities at the NRHS extension. The YMCA provided childcare for 86 children while their parents took part in ESL classes by the Literacy Zone. There were 156 children and parents who enjoyed the Family Recreation Swim Nights held at North Rockland High School. The YMCA Membership Department is located at the Nyack facility which provides member services in the gymnasium, swimming pool, aerobic studio, fitness center and game room. The YMCA offers many activities that strengthen families such as, Family Swim Nights and Healthy Kids Day at its main facility. Overall, the YMCA served 4,912 members and 1,987 program participant members. Of all those, forty-six percent of YMCA members are youth and teens. In 2016, 1544 youth and 918 adults of low income families received \$249,005 of financial assistance and program subsidies for membership and to take part in YMCA programs, thanks to generous contributions and public support. Financial assistance is available for those who cannot afford to pay the full cost of membership or programs.
