In 2016 BtGA completed the Peace Bridge using new suspension bridge design. We also rebuilt the CNN Bridge, the Machine Bridge, and the Wakor Bridge. We began construction on the 30 meter Kakenya's crossing suspension bridge in addition to another 30 meter suspension bridge in Trans Mara, Kenya. During 2016, we formed partnership with Engineers Without Borders Orange County and began relationships with organizations in Australia and New Zealand interested in building bridges in Kenya and Ethiopia. We successfully organized two fundraiser events in Atlanta, GA and New Hope, PA. We also participated in various bridge conferences in the U.S. and we delivered presentations at conferences in Ohio, Pennsylvania, Georgia, and California.
