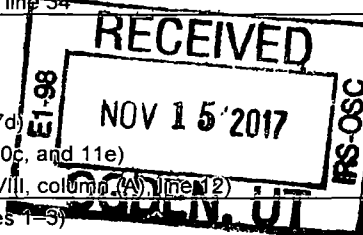

It sponsored 19 training communities, 1 conference to encourage being committed to world missions, and trained over 800 people in evangelism.
