Project Access Northwest's Primary Link program continued to link uninsured and Medicaid emergency department users whose presenting diagnosis are for non-emergency health care needs with community health centers and other resources to assist the patient in getting his or her health care and other social service needs met in a less costly setting. Mid-2016, the program also piloted serving Medicaid enrollees in the in-patient setting by making sure the patients had primary care visits scheduled prior to discharge - and the visits were within two weeks of discharge. Research on the outcomes of both aspects of Primary Link will determine the long term viability of these programs.

Project Access Northwest links low income uninsured and underinsured King, Kitsap and Snohomish County patients to volunteer specialty providers in Project Access NW's distributed network of care. Working with the community health centers and free clinics for primary care services, Project Access NW assures access to needed specialty care services by providing care coordination services for the patients. Project Access NW assures that the client is eligible for services, that the pre-visit information such as labs and imaging are available to the specialists at the time of the scheduled appointment. Supported by our care coordinators, the patients have a better than typical no-rate (about 5% compared to 30+% for typical uninsured or Medicaid patients), are more likely to show up on time and be prepared to work with the specialist on his/her care. In 2016, 2,799 patients were appointed by Project Access NW for medical services in our three county service area. They were served by over 1,600 licensed clinicians.

Form 990, Part III, Line 4b:

Project Access Northwest links low income uninsured and underinsured King and Snohomish County patients with volunteer dental providers in Project Access NW's network of care. In King County, Project Access NW's focus is on complete oral specialty care services, oral health clearance prior to organ transplantation and dentures. In Snohomish County, the focus includes oral care services including restorative care. In partnership with the community health centers and free clinics, Swedish Community Specialty Clinic and dentists in private practice, Project Access NW provides care coordination services to assure patients are eligible, have a qualifying oral health need and have the pre-visit dental treatment plan. In 2016, 2,711 were appointed by Project Access NW for dental services and served by close to 100 dentists and dental clinicians.

Form 990, Part III, Line 4c:

Project Access Northwest's Premium Assistance Sponsorship Program was developed late in 2013. Enrollees were able to purchase health care insurance in the Washington State Health Benefits Exchange, not eligible for AppleHealth (Medicaid) and unable to afford the remaining monthly premium even after federal subsidy via tax credits have been applied. In 2016, we were able to enroll and maintain health insurance for 202 covered lives for the policy year that began in January and ended in December, 2016.
