Because Aspire is currently transitioning its fiscal year to July 1 - June 30, the following narrative covers programming and accomplishments from 7/1/16 - 6/30/17 Aspire Education Project was founded as a nonprofit in the fall of 2005 in order to advance educational equity in the Bay Area We bring high-quality tutoring and personalized learning to students who do not have ready access to those services During the school year, we provide tutoring, mentoring, and standardized test preparation to students in their homes, at after-school centers, and in partnership with schools and other organizations In the summers, we flip the equation and empower teens to become teachers themselves, bringing one-on-one reading relationships to Oakland's youngest and most vulnerable via the Community Reading Buddies program (CRB) Through CRB, over 200 teens become trained literacy instructors for our community's youngest and most at-risk readers preK - 3rd graders from low-income families and disadvantaged backgrounds In pairs, teens and their "buddies" read and connect all summer, forming relationships and building skills critical for success in school As with all of our programming, Community Reading Buddies nurtures both educational equity and community bonds FY 2016 Accomplishments Aspires model relies on fee-for-service work to finance our endeavors to reach the underserved with high-quality supplemental educational support We charge competitive market rates for one-on-one tutoring and test prep classes among private schools and families that can afford them We pay tutors well, and operate in many ways like a for-profit business Any profit that is generated, however, is used to fund other programming that we do at or below cost This programming includes rate reductions for individual students that have demonstrated financial hardship, test prep classes at schools or other nonprofit organizations supporting underprivileged students, and pre-kindergarten literacy engagement among the underserved via our Community Reading Buddies program In FY 2016, Aspire served a total of 1355 students, with approximately 945 (70%) eligible for Free and Reduced Price Lunch, through the Federal Free or Reduced Price Meal Program (FRMP) By program area, we served -776 high school students with SAT/ACT classes and after school programming-190 students with private tutoring, 14% in K-8 and 86% in high school-150 low-income preK - 3rd graders in the Community Reading Buddies program-239 middle and high school "Youth Mentor" volunteers, from 62 different schools2016's Community Reading Buddies was a success, with universally positive feedback from parents, classroom teachers, and the teenage Youth Mentors Pre and post testing of the preK - 3rd graders revealed significant gains in phonemic awareness, print motivation, self regulation, and other key school readiness measures Additionally, we set a new record in our volunteer return rate (27%), and recruited teenage Youth Mentors from 48 different schools, another high-water mark In total we provided 2650 hours of high-quality, one-on-one literacy instruction to the East Bays young underserved students of color who needed them most Programs and Partnerships were held in collaboration with 18 local institutions, including the Lawrence Hall of Science, East Bay College Fund, the SHE-CAN foundation, Girl's Inc, Boys & Girls Club of San Francisco, Student Program for Academic and Athletic Transition (SPAAT), and the Peralta colleges Aspire served 443 students total in this program area, and once again achieved average gains of 160 points for the SAT and 3 points for the ACT Aspire's leadership remained consistent in 2015, with Jack Woodruff continuing in the ED position and Aspire's board president remaining local attorney Yelda Bartlett
