The Journey Home is a Christian ministry whose primary focus is to serve the homeless and disadvantaged of Rutherford County - providing practical resources for body, mind, and spirit, and encouragement on their journey to economic stability and reintegration into community life. Shelter, housing, food staples, meals, clothing, hygiene services, computer lab and employment resources, counseling/care coordination, rent and utility assistance, transportation assistance are examples of services provided.

The Journey Home provided hunger relief to the homeless and needy in the community through our Community Cafe program. During 2016, we served meals seven days a week, providing nearly 48,000 meals. Additionally, the Community Cafe program provided boxes of food staples, dairy and produce. More than 3,000 boxes were distributed to clients at our outreach center. Much of the produce was grown at our community garden, which also provides employment opportunities for clients. The Cafe bread room also provides bread and baked goods daily for clients to take as they leave the center. All of this is provided at no charge to the clients to meet basic needs as well as an engagement tool for other programs.

4b (Code: 624200) (Expenses \$ 255,104 including grants of \$) (Revenue \$)
The Journey Home provided shelter, housing, case management and supportive services through our Housing Programs. Housing programs range in scope including cold-weather emergency shelter (which served 180 persons during this calendar year), homelessness prevention services which keep people from losing their housing and becoming homeless (39 persons served), re-housing of the homeless into market place housing (63 persons served), and our supportive and transitional housing programs that provide longer-term housing solutions for families and individuals wrapped in supportive services as they get back on their feet and reintegrate into community life (79 served). Shelter program operated from November through April. Other programs operated all year.

The Journey Home assisted the homeless and needy in the community with clothing, laundry, showers, hygiene items, counseling, financial assistance, and case coordination through our Outreach Center. Clients was two loads of clothes weekly and attain clothes from the clothing closet. All clothing is donated and free of charge to clients. We provide hygiene supplies and showers, which are used daily. Examples of financial assistance include help with past-due rents and utilities, gas vouchers and bus passes, car repairs to get to work, work uniforms, assistance getting identification, assistance with medicine costs, and the like. More than 100 persons are served daily at the outreach center.
