MAZON A Jewish Response to Hunger (the Organization) is a national nonprofit working to end hunger among people of all faiths and backgrounds in the United States and Israel MAZON, which means "food" in Hebrew, was the first national organization to rally the American Jewish community around the issue of hunger, and remains the only national Jewish organization dedicated exclusively to that same cause Since its founding in 1985, the Organization has established itself as a leader in the national anti-hunger movement The Organization founded and continues to chair NAHO (National Association of Hunger Organizations) and participates in a number of other anti-hunger and interfaith coalitions It also works in close collaboration with interfaith agencies of all denominations to advocate on behalf of hungry families nationwide

The Organization works to ensure that hungry people have access to the resources they need to survive while simultaneously striving to develop and advance long-term solutions that will end hunger once and for all It employs a holistic approach to accomplishing its mission, which it demonstrates through its three interrelated strategies Partnership Grantmaking The Organization makes annual partnership grants that help carefully screened partner organizations work to end food insecurity in their communities Since awarding its first grants in 1986, the Organization has awarded grants totaling more than \$80 million to partners who represent the entire spectrum of the nation's anti-hunger network FY2016 Program highlighto The Organization funded 15 first-time grantees in high-need states like West Virginia, Kansas and Nebraska where MAZON currently has few grantee partners Strategic InitiativesThe Organization develops and implements strategic initiatives designed to encourage the anti-hunger community to effectively address emerging issues These initiatives have focused on advancing strategies to increase access to healthy food in the emergency food network, senior hunger and hunger in rural and remote areas of the United States FY2016 Program highlightso The Organization is working in partnership with the Shakopee Mdewakanton Sioux Community and the Indigenous Food and Agriculture Initiative at the University of Arkansas to develop model food and agriculture codes that can be customized and adopted by tribal governments This trailblazing project seeks to overcome legal and regulatory roadblocks to tribal nations' ability to encourage agricultural production on their own lands and advance health and food security in Indian Country o The Organization initiated the second phase of its national Solutions to Senior Hunger initiative Thirteen Jewish Family and Children's Service agencies in 13 states served as on the ground partners for this initiative, which focused on educating seniors about their eligibility for federal food assistance and helping eligible seniors apply to receive help that could make a difference Education, Outreach & AdvocacyThe Organization also develops and implements programs to educate students of all ages about the reality of hunger as well as to empower them to become informed advocates in the fight to end hunger The Organization promotes change as a means for ensuring not only that food is accessible to those who are hungry today, but also that no one goes hungry tomorrow FY2016 Program highlights o The Organization continued its work to explore the causes and responses to the growing need for food assistance among veterans and currently serving military personnel In FY2016, MAZON offered two webinar trainings to the 12,000 social workers, dietitians and chaplains working at the Veterans Administration to educate them about food insecurity and how to connect veterans to SNAP benefits o The Organization began planning and designing "This Is Hunger," a multi-year community engagement program that will educate the Jewish community about the realities of hunger, and encourage them to raise their voices on behalf of the millions of Americans who struggle with hunger every day The centerpiece of This Is Hunger is a traveling photography and storytelling exhibit that will visit synagogues, Jewish community centers, and museums in major cities across the country o The Organization's MAZON Advocacy Program (MAP) initiative continues to mobilize synagogues and the broader Jewish community and teaches them how to identify relevant information, partners and resources so they can advocate on behalf of hungry people in their communities In FY2016, the Organization led ongoing initiatives in Minnesota and Pennsylvania and initiated efforts in New Mexico and New Jersey o The Organization expanded its program aimed at educating and engaging youth attending Jewish summer camps in the fight to end hunger In FY2016, the Organization educated 1750 campers at 12 camps BJE Teen Service Corp Summer Program in Los Angeles, CA, Camp Alonim in Brandeis, CA, Camp Bob Waldorf in Glendale, CA, Capital Camps in Waynesboro, PA, Habonim Dror Camp Moshava in Street, MD, Habonim Dror Camp Na'aleh in Windsor, NY, URJ Camp Newman in Santa Rosa, CA, URJ Crane Lake Camp in West Stockbridge, MA, URJ Eisner Camp in Great Barrington, MA, URJ Greene Family Camp in Bruceville, TX, Wilshire Boulevard Temple's Gindling Hilltop Camp in Malibu, CA, and Young Judea's Camp Sprout Lake in Verbank, NY The Organization raises funds by requesting donations from the American Jewish community and soliciting grants from Foundations The Organization has nearly 1,000 synagogue partners nationwide and strong relationships with the organizing bodies of the Reform, Reconstructionist, and Conservative movements as well as a broad spectrum of other Jewish organizations
