The 2016 five-day/four night camp sessions took place in two locations Western North Carolina (YMCA Camp Harrison in Boomer, NC), and near Atlanta, Georgia (Camp Twin Lakes in Rutledge, GA) Camps were leased for one-week programs in March and October The website is maintained for camper sign-up and for recruitment of volunteers There is extensive planning for camp sessions for adults with developmental disabilities The Georgia camp session was held March 14-18, 2016 and served 67 disabled adults with help from 63 volunteers The first North Carolina session was held October 1-5, 2016 and served 55 disabled adults with help from 45 volunteers The second North Carolina session was held October 8-12, 2016 and served 66 disabled adults with help from 45 volunteers
