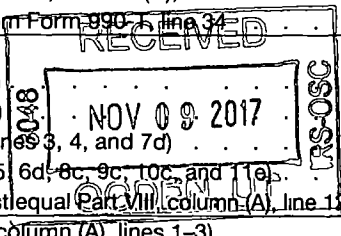

ACCO produced a series of nationally recognized education and training conferences including two Climate Strategies Forum events in Washington, DC and San Diego, the Integrated Renewables Workshop and Operation: Supply Chain Workshop. Our 2015 Rising Seas Summit (produced in collaboration with the City of Boston) shows most of the expenses in 2016 due to the invoicing taking place after the event. Additionally, the 4th annual (2016) Rising Seas Summit was ultimately canceled at a cost to ACCO as a result of the change in Administration as Federal personnel that would have be critical to the event were unable to participate.

The Future Climate Change Officer Fellowship Program (Future CCOs) is designed to connect masters level graduates who have focused their studies upon climate change or sustainability (and have formal education in business, law, engineering, public policy and/or communications) with companies, universities and government entities to work on climate change related response efforts (e.g. supply chain management, GHG management, adaptation and resilience, disclosure and investor relations, etc.).

ACCO produces a series of regional training programs called Climate Fundamentals Academies designed to prepare participants for testing for ACCO's professional credentialing. Training events in 2016 were hosted in South Florida, Northern California, Golden (Colorado) and Washington, DC.
